Dear Sir,

I, Sanjay Dholakia & Associates, Practicing Company Secretaries, represented by Mr. Sanjay Dholakia, (Membership No. FCS - 2655), Proprietor, was appointed as the Scrutinizer for the purpose of the remote evoting process prior to the Extra Ordinary General Meeting (EOGM) and e-voting process during the EOGM pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 read with MCA General Circular No. dated 5th May, 2020 read with circulars dated 8th April, 2020, 13th April, 2020, 13th January, 2021, 14th December, 2021, 5th May, 2022, 28th December, 2022, 25th September, 2023 and 19th September, 2024 (collectively referred to as "MCA Circulars") permitted the holding of the "EOGM" through Video Conferencing (VC) / Other Audio Visual Means (OAVM in respect of below mentioned resolutions proposed at the EOGM of **Pioneer Embroideries Limited** held on **Friday, 8th November, 2024 at 11.00 A.M.** through Video Conferencing / Other Audio Visual means (VC/OAVM).

The Members of the Company holding shares on the record date ("Cut off" date) of Friday, 01st November, 2024 were entitled to vote on the resolutions as set out in the notice of said EOGM.

In this regard, we hereby submit my report as under:

 The Company had availed the e-voting facility offered by Link Intime India Private Limited (LIIPL) for conducting remote e-voting prior to EOGM and e-voting during the EOGM by the Members of the Company.

- The remote e-voting prior to EOGM period remained open from Tuesday, 5th November, 2024 (9.00 a.m. IST) to Thursday, 7th November, 2024 (5.00 p.m. IST) and LIIPL Insta Vote e-voting platform was disabled thereafter.
- 3. The Company had also provided e-voting facility to the Members present / logged-in at the EOGM through VC and who had not cast their vote earlier.
- 4. We have also received a complete record of votes cast through electronic mode, upto 5:00 p.m. on 7th November, 2024 from LIIPL, the agency appointed for providing and supervising electronic platform. The votes cast were unblocked on 08th November, 2024 at 11.30 a.m. (IST) in the presence of two witnesses, who are not in the employment of the Company.
- 5. We have scrutinized the votes cast through both remote e-voting and e-voting during the EOGM processes for the purpose of this report.
